(Not necessarily what I wanted). What a relief to get an answer, to feel lighter and unstuck, after this work. Work step six.

Any time I don't think I've "earned" my chair in this program - ie, my food's not perfect, my story doesn't include drastic weight gain/loss, I feel like I don't belong...I must remember that I

have **P.A.I.D**. the price of admission - with **P**itiful **A**nd **I**ncomprehensible **D**emoralization. That's all I need to be a member of OA - the desire to NEVER go back to that place that compulsive eating brought me.

As long as I remember that I never have to go back to where I came from, I know I'm in the right place.

But of course, it's not, as so much else isn't these days. I choose instead to remember words from "Acceptance is the Answer" in the Big Book . . . "When I am disturbed, it is because I find some person, place, thing, or situation ... unacceptable to me, and I can find no serenity until I accept that person, place, thing, or situation exactly the way it is supposed to be at this moment. Nothing, absolutely nothing, happens in God's world by mistake." (p. 417)

I remember that I am not in charge of our big beautiful universe, much less today's snow and wind . . . thankfully. I remember, instead, that I am in charge of my awareness, my acceptance, and my actions, the 3 A's of program. I am certainly aware of my old patterns, which led me, fresh out of ideas and willpower, to the doorstep of OA. I gratefully accept this insight today, this chance not to throw a temper tantrum over a snowstorm and instead to formulate an action plan.

As a result, I can accept today "exactly as it is supposed to be in this moment," and I can ask, What next? ... which offers solutions. I have choices. I can bundle up and take a walk after all, loving this blustery icy world, grateful to a higher power for all we have been given. I can nestle into a warm house and knit. I can check in with my sponsor. I can call another OA member just to say hello and ask, "How are you doing?" And . . . I can even use the tool of writing to wind my way back into the "sunlight of the spirit." Lucky me. Lucky us.

Q: If a member refuses to introduce him or herself as a compulsive overeater but simply as an "overeater," can he or she take on service positions? Does it make a difference if the member has a sponsor and says he or she is working the Steps?

A: Members may call themselves whatever they want. Over the years I have heard many variations in OA meetings—compulsive overeater, compulsive undereater, compulsive over-exerciser, grateful, sugar addict, carbohydrate addict, food addict, recovered bulimic, restrictor, anorexic, you name it. As Tradition Three says, "The only requirement for OA membership is a desire to stop eating compulsively."

For service positions, the requirements for each position are up to the group conscience. Usually the requirements are based on time in the program and period of abstinence. Willingness to serve also helps. To encourage service, it is good to have positions with little or no requirements, such as setting up chairs. In accordance with Tradition Four, the requirements for a

position can vary widely from group to group.

If a member has a sponsor, is working the Steps, and is willing to do service, then the member and the group are very fortunate when there is a service position to be filled. Since service is a Tool that enhances our program of recovery on all levels for OA as a whole, it seems wise to create as few barriers as possible to doing service. From group experience it usually becomes clear what each position requires.

The OA Handbook for Members, Groups and Service Bodies: Recovery Opportunities has many wonderful suggestions. For instance, under the heading "What Are Some Good Qualifications for Service Volunteers?" it is stated, "Experience has shown that giving members a job solely to help them maintain abstinence does not work; instead the group's welfare should be of primary concern in choosing members to fill the service positions. A review of Traditions One and Two is helpful at election time. "Service volunteers should fully realize that giving service to a group may sometimes involve doing tasks whether they feel like it or not" (pp. 16-17).

You may want to get a copy of this useful pamphlet for your group. It is available for purchase on oa.org in the bookstore.

After taking my inventory, I realized that I experienced fear. I have had bad experiences with groups and intergroups that do not adhere to the Traditions and/or when members do not follow the group conscience. However, I realize that God or our Higher Power is in charge. I fully understand and agree with Bill W.,

The same stern threat applies to the group itself. Unless there is approximate conformity to A.A.'s Twelve Traditions, the group, too, can deteriorate and die. So we of A.A. do obey spiritual principles, first because we must, and ultimately because we love the kind of life such obedience brings. Great suffering and great love are A.A.'s disciplinarians; we need no others.

It is clear now that we ought never to name boards to govern us, but it is equally clear that we shall always need to authorize workers to serve us. It is the difference between the spirit of vested authority and the spirit of service, two concepts which are sometimes poles apart. It is in this spirit of service that we elect the A.A. group's informal rotating committee, the intergroup association for the area,

and the General Service Conferences of Alcoholics Anonymous for A.A. as a whole. Even our Foundation, once an independent board, is today directly accountable to our Fellowship. Its trustees are the caretakers and expediters of our world services.

If I or we deviate too far from our spiritual principles God will step in. I do not have to live in fear. However, as I stated in my last Chair Report, all of us are the guardians of our principles, and as such we say something if we feel our spiritual principles are not being adhered to and then let it go of it. We let go and let God.
